Whereas, from perusal of record, it has been found that the petitioner is working at GMS Shidhari, U/C GSSS Ghaniar, Saraj-11, Distt. Mandi, w.e.f. 08.03.2019 and has completed the normal tenure of three years. However, no stations of his are vacant at this stage and also there is no person who has completed his normal tenure. Therefore, after careful application of mind, it is decided that since the Department of Higher Education is going to make promotions to the post of School Lecturer (New) from amongst the eligible Trained Graduate Teachers in near future, hence the petitioner will be given posting at a suitable place as and when the vacancy will arise at his place of choice. The representation of the petitioner is disposed of accordingly.
