On the subject cited above, it is to inform you that your name was recommended by the Secretary, HPSSC, Hamipur vide letter No.HP-SSC-C(2)6/2018-17710 dated 17.08.2019 for the post of TGT (NM) under Gen-BPL category, however, in the letter at point no. 5 of note it was mentioned that 'The candidates at Sr. No. 23, 98, 117, 145, 168 of the recommendation list have also been recommended subject to verification of their BPL certificate as they have submitted the certificate of Non-employment as well as experience certificate as SMC on Grant in Aid basis". Your name was at Sr. No. 98 in the recommendation list. Accordingly, the Department asked the Director, Rural Development Department H.P. Shimla-09 to inquire into the matter and the Director, Rural Development Department, Himachal Pradesh Shimla-171001 vide letter No. SMP-7/2010-(Bud)RDD-XIX-10040 dated 28.12.2022 informed that the Assistant Commissioner (Development)-cum-Block Development Officer Salooni, District Chamba vide his office letter No. 8416 dated 09:12.2022 has informed that a Fact Finding Committee was constituted by him to ascertain the BPL status of the family of Sh. Deepak Kumar S/o Sh. Chaudhary Ram and the continuation of such status despite the engagement of Sh. Deepak Kumar as SMC Teacher (GIA Basis). As per the Committee's report, the family was selected in the BPL category in the year 2007 and the Gram Panchayat had not received any intimation from the family or Sh. Deepak Kumar with regard to the engagement of him as SMC Teacher on 05.07.2016. It is also found by the Committee that a total number of 15 Gram Sabha meetings were held between 09.07.2016 to 11.02.2020 and the Gram Sabha had not received any objection regarding BPL status of his family during such period. Later, on receipt of intimation of selection of Sh. Deepak Kumar as TGT(Arts), the Gram Sabha has removed the name of Sh. Deepak Kumar from the BPL list. vide resolution No. 42 dated 15.03.2021.
