The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 14-06-2023 when the Hon'ble High Court has passed the following orders:-

" 3. *Learned counsel representing the respondents-State, states that the 2nd respondent will decide the said representation within a period of four weeks and communicate his decision to the petitioner.*"

Whereas, petitioner was submitted his representation to this office on 21-06-2023 vide which he has requested that he has completed required tenure at his present place of posting at GMS Sumra, U/C GSSS Chango, Distt. Kinnaur, H.P and he further requested that he may be transferred from GMS Sumra, U/C GSSS Chango, Distt. Kinnaur difficult area to Distt. Bilaspur, H.P. He has given five stations if his choice in District Bilaspur, H.P.

From perusal of record, it has been found that the petitioner is working in GMS Sumra, U/C GSSS Chango, Distt. Kinnaur, H.P since 18-11-2019, as total service of petitioner in difficult sub cadre and has completed more than three years stay at present place of posting. One post of TGT(NM) is lying vacant in GHS Mangrot, U/C GSSS Ghagus, Distt. Bilaspur, H.P and (80) students are studying class 6th to 10th in this school. Keeping in view the above facts and circumstances the representation of the petitioner is considered sympathetically and he is hereby transferred on his own request from GMS Sumra, U/C GSSS Chango, Distt. Kinnaur, H.P to GHS Mangrot, U/C GSSS Ghagus, Distt. Bilaspur H.P, against vacancy. The representation of the petitioner, is disposed of accordingly.
