Sh. Ramesh Chand, TGT (NM) preferred CWP No. 3050/2023 titled as Ramesh Chand, TGT(NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GSSS Lamu, Distt. Chamba, H.P to soft area in Distt. Kangra, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 23-05-2023 when the Hon'ble High Court has passed the following orders:-

" 4. In view of above, petitioner is permitted to make representation to the competent authority alongwith supported documents on or before 30.05.2023. In case such representation is preferred, same shall be decided by the competent authority on or before 20.06.2023, by passing a speaking and reasoned order, after giving option of personal hearing to the petitioner, if desired so. Order shall be communicated to the petitioner immediately thereafter. In case, station(s) mentioned in the representation is/are lying vacant, then at least, one of such stations shall not be filled, if not already filled, till the decision of representation."

In the compliance the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 20.06.2023. He attended the same and submitted his representation in this office vide which he is serving since 09-05-2023 in GSSS Lamu, Distt. Chamba, H.P and he further requested that he may be transferred from GSSS Lamu, Distt. Chamba tribal area to Distt. Kangra. He has given five stations of his choice in the aforesaid representation.

From perusal of record, it has been found that the petitioner is working in GSSS Lamu, Distt. Chanba since 09-05-2023 which falls in tribal/ hard area, however prior to this petitioner was already working in GHS Nayagan tribal / Hard area since 02-12-2019 to 09-05-2023 in Distt. Chamba and has completed more than three years stay at tribal / Hard area. One post of TGT(NM) is lying vacant in GSSS Karanghat, Distt. Kangra and (37) students are studying class 6<sup>th</sup> to 10<sup>th</sup> in this school. Keeping in view the above facts and circumstances the representation of the petitioner is considered sympathetically and he is hereby transferred on his own request from GSSS Lamu, Distt. Chamba to GSSS Karanghat, Distt. Kangra, H.P, against vacancy. The representation of the petitioner is disposed of accordingly.
