**ORDER**

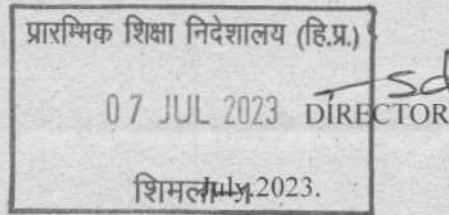
**In the matter ? CWP No. 1879/2023 titled as Anil Kumar,TGT(Med)VS State of H.P. & others.**

The Petitioner, Sh. Anil Kumar ,TGT(Med) filed CWP No. 1879/2023 titled as, Anil Kumar,TGT, (Med),versus State of H.P. before the Hon'ble High Court of H.P.regarding his transfer from GSSS Dharchandna (Kupvi) Distt. Shimla ,(which fall under hard area ) to his choice of station after the completion of required tenure as per policy. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 13<sup>th</sup> june,2023, when after hearing the matter,the Hon'ble High Court has disposed of the same with the following directions/ order:-

*" In the given facts and circumstances,we deem it appropriate to dispose of the instant petition with a direction to the respondents to consider ,decide and thereafter issue consequential order of transfer of the petitioner to anyone of the five stations opted by him in representation (Annexure P-3) within a period of four weeks .Ordered accordingly .Pending application (s),if any also stands disposed of."*

As per direction of the Hon'ble High Court the petitioner submitted his representation to the undersigned,in which he has requested that he may be adjusted at GSSS Bhareri /GGHS Dhaneta /GHS Baloh/ GHS Ropari /GSSS Dhangota /GHS Tauni Devi/GHS Kudher/GHS Nahalwin/GSSS Kharwar Distt. Hamirpur/ GSSS Bharari(BLP) or anywhere in Distt. Bilaspur/Hamirpur due to promotion of present incumbent.

From the perusal of the record, it reveals that Sh.Anil Kumar,TGT(Med), is presently working in GSSS Dharchandna (Kupvi),Distt.Shimla, (which fall under hard area) since 11<sup>th</sup> March,2019 and has completed his normal tenure at present place of posting. I find it appropriate to transfer the petitioner to GHS Ropari Distt. Hamirpur against vacancy being casued due to promotion of present incumbent. These orders will be implemented after relieving of promtee teacher. With these observations the representation of the petitioner is considered and disposed of accordingly.
