Whereas, Shri Ram Pal, TGT (NM) preferred CWP No. 4342/2023 titled as Ram Pal Vs. State of H.P. before the Hon'ble High Court of H.P. against his transfer from GHS Sahali, Tehsil Pangi, Distt. "4. Even though, the petitioner has made representation P-3 and P-4, however the same are not in conformity with the comprehensive guiding principles-2013. Therefore, in such circumstance, we deem fit appropriate to permit the petitioner to file a fresh representation clearly setting out therein five stations of his choice, of which one essentially has to be out of his home district. Ordered accordingly. In the event of such representation being filed within one week, the respondents shall consider, decide and thereafter issue consequential order of transfer of the petitioner to one of the stations of his choice, within a period of two weeks thereafter."

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner has submitted his representation and requested that he may be transferred in the stations nearby his native place against vacancy/longer stayee. The petitioner has requested to transfer him at GSSS Mohal, GSSS Bagan, GMS Shamshi U/c GSSS Mohal, GHS Khokhan Distt. Kullu against vacancy/longer stayee.

Whereas, from perusal of record, it has been found that the petitioner is working at GHS Sahali (hard area) Teh. Pangi, District Chamba since year 2007 and has completed three years stay. At present one post of TGT(NM) lying vacant in GSSS Mohal, Distt. Kullu and (357) students are studying in the schools mentioned by the petitioner in his representation. Keeping in view of the above position, the representation of the petitioner is considered sympathetically and he is hereby transferred from GHS Sahali (hard area) Teh. Pangi, District Chamba to GSSS Mohal, Distt. Kullu against vacancy, without TTA/JT. The representation of the petitioner is disposed of accordingly.
