In the matter : CWP No.3800/2023 titled as Vikram Chand,TGT (Med) Vs state of H.P. & others .

The Petitioner,Sh.Vikram Chand,TGT,(Med) filed CWP No. 3800/2023 titled as, Vikram Chand Vs State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Buchhair Distt.Kullu after the completion of required tenure as per policy. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 13<sup>th</sup> June, 2023, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-p

*"Learned counsel for the State,on instructions,states that the 2<sup>nd</sup> respondent will decide the state representation dated 18-10-2022(Annecure P-2) within four weeks in accordance with law and decision taken by 2<sup>nd</sup> respondent shall be communicated to the petitioner .The writ petition is disposed of in view of above statement of learned counsel for the State."*

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated 27<sup>th</sup> June,2023. The petitioner attended the personal hearing on scheduled date and time .During personal hearing he has requested that he may be adjusted in GHS Ropari/ GHS Kudhar/ GHS Nahalwin/ GGHS Dhaneta Distt. Hamirpur and GSSS Kathiana against vacancy (due to promotion of present incumbent / against longer stay).

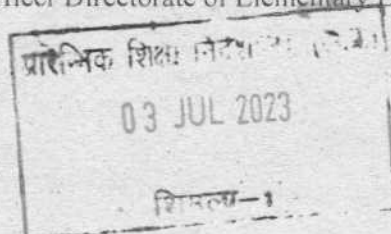
