ORDER

In compliance to the orders passed by the Hon'ble High Court of Himachal Pradesh, in CWP No. 8617/2024 titled as Sonia Verma, TGT (Arts) V/s State of H.P. on dated 23-08-2024, the petitioner was called for personal hearing on 04-10-2024, on this day, the petitioner has submitted her fresh representation with the request to adjust either at GHS Jogipur, GSSS Kachiyari or GSSS New Kangra, District Kangra, on medical grounds.

On the perusal of record, it is revealed that Smt. Sonia Verma, TGT (Arts) is working at GSSS Bankhundi (soft area) District Kangra since 17-01-2019 and has completed normal tenure at her present place of posting, which is only 28 Kms. away from her native place in same district.

In this connection it is found that Smt. Sonia Verma, TGT (Arts) is working at GSSS Bankhundi (soft area) District Kangra wherein the enrollment of students is 131 (Aprx.) and at present post of TGT (Arts) is not lying vacant at the schools given by the petitioner. As per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees, it is specifically mentioned in Para 12.1 "All employees during their period of service will serve for at least single tenure in the Tribal/difficult/ Hard area and remote/ rural areas. Transfer to a particular place of choice cannot be claimed as a matter of right. It will be the discretion of the State Govt., to post/transfer any employee anywhere in the state, keeping in view of the administrative exigencies/convenience." Therefore, being a State cadre Government employee, the request of the petitioner is not tenable and hereby rejected.
