Regarding regularization of Left out Para Teachers.

I am directed to refer to your letter No. EDN-H (Ele-III)01/2019-PTA, dated 11th June, 2020, on the subject cited above and to convey approval of the Govt. for regularization of Left Out 97 Para Teachers engaged in Elementary and Higher Education Departments subject to the following conditions:-

1. Left Out Para teachers who have acquired the requisite qualifications and eligibility criteria, as per R&P Rules in vogue can be considered for regularization on notional basis from the date of the regularization on which their counterparts were regularized, retrospectively and actual from the date which is to be notified by the Department Prospectively.
2. Department may ensure that on the date when counterparts of 97 Para Teachers under reference were regularized, these 97 Para Teachers also fulfilled the essential qualifications/eligibility criteria as per Para Teacher Policy/R&P Rules of respective category. If there are any Para Teachers within this group of 97 Para Teachers, who were not qualified at that time, their case may be moved by the Department separately.
3. All those Left Out Para Teachers who do not have requisite qualification/eligibility till today cannot be considered for regularization.
4. Before regularization the Department may also ensure that there is no pending litigation in the Hon'ble High Court or any other Court arising out of recent judgment of the Hon'ble Supreme Court in this regard.

You are, therefore, requested to take further necessary action in the matter after completing all codal formalities under intimation to this Department.

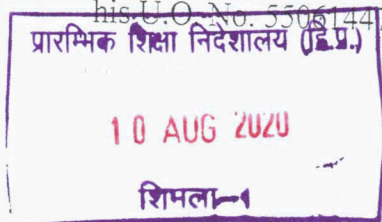
