Whereas, Sh. Sanjeev Kumar, TGT (NM) preferred CWP No. 8165/2022 titled as Sanjeev Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Maingal u/c GSSS Shillgharat District Chamba to the station of his choice. Whereas, the petitioner was called for personal hearing on 22.02.2022 and and he attended the same. He has requested for his transfer from his present place of posting to the stations of his choice in District Kangra against vacancy.

From perusal of record, it has been found that the petitioner has been working at GMS Maingal u/c GSSS Shillagharat District Chamba w.e.f. 15.11.2019 and has completed three years stay. At present one post of TGT(NM) is lying vacant in GMS Bleer u/c GSSS Mohtli District Kangra. Therefore, after thoughtful application of mind, the request made by the petitioner is considered and he is hereby transferred from GMS Maingal u/c GSSS Shillagharat District Chamba to GMS Bleer u/c GSSS Mohtli District Kangra against vacancy on administrative ground and in larger public interest. The representation of the petitioner is disposed of accordingly.
