Whereas, Smt. Yamuna Devi, TGT(NM) preferred CWP No. 525/2023 titled as Yamuna Devi Vs. State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GMS Jhalwari u/c GSSS Jangla District Shimla to the station near to her native place. She further requested her husband is Physically challenged person with disability to the extent of 64% and also serving in Higher Education as Lecturer at GSSS Dehar District Mandi. So, being a couple case she may please be transferred to the station given by her in the representation.

From perusal of record, it has been found that the petitioner has been working at GMS Jhalwari u/c GSSS Jangla District Stimla w.e.f. 21.11.2019 and has completed more than three years stay. Her husband is serving at GSSS Dehar District Mandi as Lecturer in Higher Education Department. Therefore, after critical examination and thoughtful application of mind the request made by the petitioner is considered sympathetically and she is hereby transferred, without TTA/JT, from GMS Jhalwari u/c GSSS Jangla District Shimla to GMS Parnali u/c GSSS Bandla District Bilaspur against vacancy, on administrative ground and in larger public interest. The representation of the petitioner is disposed of accordingly.
