ORDER

Sh. Rajesh Kumar , TGT(Arts) presently working in GSSS Ranol (SML) has
filed CWP No.4456/2020- before the Hon'ble High Court regarding transfer from the present school.
CWP was disposed of on 14.10.2020 with the following directions:-

The instant writ petition is disposed of with a direction to the respondent
concerned , to, decide Annexure P-3, within a period of four weeks, after
affording an opportunity of personal hearing to the petitioner.. It is also open,
for the petitioner, to mention the stations of his choice during personal hearing
other than the one(s) already carried in the afore representation. All pending
applications stand disposed of accordingly.

In-compliance to the order passed by the Hon'ble High Court, the petitioner
was called for personal hearing on 5.11.2020 but he didn't turn up on the scheduled date. One more
chance of personal hearing was afforded to him on 27.11.2020 which was attended by the petitioner.

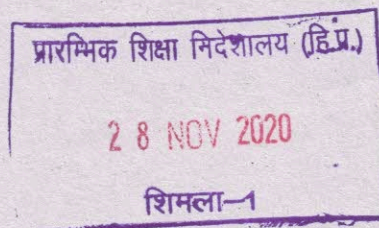
During personal hearing the petitioner submitted representation wherein he has
requested that he may be transferred from GSSS Ranol (SML) to either G(G)SSS Jawalamukhi (KGR)
or GSSS Sunhet (KGR) against vacancy.

From perusal of record it has been noticed that the petitioner is working in
GSSS Ranol (SML) w.e.f. 17.11.2016 and has completed normal tenure. Post of TGT (Arts) is not
vacant in G(G)SSS Jawalamukhi (KGR). Hence, he is hereby adjusted in GSSS Sunhet (KGR) against
vacancy as per order of the Hon'ble High Court passed on 14.10.2020 wherein it has been directed
that petitioner, will mention the stations of his choice during personal hearing other than the
one(s) already carried in the afore representation. *These orders are in-view of
provisions contained in 16.2 of transfer Policy.*
Accordingly representation stands decided.
