Whereas, Smt. Soma Devi, TGT(NM) has filed CWP No. 2200/2021 titled as Smt. Soma Devi Vs. State of H.P. before the Hon'ble High Court of H.P against her transfer from GSSS Galma Distt. Mandi to GHS Thangi District Kinnaur vice Sh. Lal Man, TGT(NM) & vice-versa. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 05.04.2021, when after hearing the matter the Hon'ble High Court has directed as under:-

"Consequently, this petition is disposed of with direction to the respondents No.1 to 3/competent authority to decide representation of the petitioner dated 30.03.2021, Annexure P-4, in accordance with law, within two weeks from today. Pending miscellaneous application(s), if any, also stand disposed of."

In compliance to the directions of the Hon'ble High Court the petitioner has attended personal hearing on 23.06.2021 and requested that she may kindly be adjusted in GMS Saletar u/c GSSS Kotali/GMS Dugrain u/c GSSS Baggi /GMS Naulakha u/c GSSS Mahadev/ GMS Tikkar u/c GSSS Balu Distt. Mandi against vacancy.

On the perusal of the record, it is found that the petitioner has been transferred from GSSS Galma Distt. Mandi to GHS Thangi District Kinnaur vice Sh. Lal Man, TGT(NM) & vice-versa in view of CWP. No. 846/2021-titled as Lal Man, TGT (NM) Vs. State of H.P. & Others. At present the post of TGT(NM) is lying vacant in GMS Saletar u/c GSSS Kotali District Mandi.

Therefore, keeping in view the position stated above, request made by Smt. Soma Devi, TGT (NM) is hereby adjusted at GMS Saletar u/c GSSS Kotali Distt. Mandi on her own requested without prejudice. The representation of the petitioner is disposed of accordingly.

In the matter of: CWP No: 2821/2021-Pawna Devi, TGT (Arts) Vs. State of Himachal Pradesh (Regarding Transfer)

ORDER

Smt. Pawna Devi, TGT(Arts) under orders of transfer from GHS Nandehar (KGR) to GMS Rajol u/c GSSS Kotla (KGR) has filed CWP No: 2821/2021-before the Hon'ble High Court regarding transfer/adjustment. The case was listed on 06.05.21, when the same has been disposed of with the following directions:-

The present petition is not maintainable, however, having taken note of the fact that petitioner has already served in hard area, this court deems it fit to dispose of the present petition with a direction to the respondents to consider and decide the representation to be filed by the petitioner within a period of one week, praying therein to adjust her at suitable place. Ordered accordingly. On receipt of such representation, respondents shall consider and decide the same within a period of three weeks. Needless to say, aforesaid respondents, while doing the needful, shall afford an opportunity of hearing to the petitioners and pass a speaking order thereupon. Liberty is reserved to the petitioner to approach appropriate Court of law, if required and desired. Till the time, representation filed by the petitioner is not decided by the authority concerned, status qua qua the posting of the petitioner shall be maintained.

Petition stands disposed of, in the aforesaid terms alongwith all pending applications.

In pursuance to the said order passed by the Hon'ble High Court the petitioner attended personal hearing on 21.6.2021 and filed representation wherein it has been requested that she may be adjusted in GHS Kholi (KGR) against vacancy which will accrue on 30.6.2021 due to the superannuation of present incumbent Smt. Anju Gupta TGT (Arts).

I have gone through the record carefully and noticed that the petitioner was transferred from GHS Nandher (KGR) to GMS Rajol u/c GSSS Kotla (KGR) on 30.4.2021 on vice versa basis with the prior approval of the competent authority. As her stay was not complete she approached the Hon'ble High Court vide CWP ibid.

The post of TGT (Arts) will be vacant in GHS Kholi (KGR) on superannuation of present incumbent on 30.6.2021, hence, the petitioner is hereby adjusted in GHS Kholi (KGR) without TTA/JT. The petitioner will join in the said school after 30.6.2021.

Accordingly representation stands decided.
