(Regarding Transfer)

**ORDER**

Smt. Pammi Devi, TGT(Arts) has filed CWP No. 847/2022-before the Hon'ble High Court regarding transfer from GSSS Lagauti, Distt.Kullu. The case was listed on 23.02.2022, when the same has been disposed of with the following directions:-

*Respondent No.2-Director Elementary Education, Himachal Pradesh, Shimla to consider and decide the representation filed by the petitioner within a period of four weeks from today, by passing a speaking order in accordance with law and applicable policy. Pending applications, if any, also stand disposed of.*

In pursuance to the orders passed by the Hon'ble High Court of Himachal Pradesh, the representation filed by the petitioner was perused carefully wherein the petitioner i.e Smt. Pammi Devi, TGT (Arts) stated that her mother in law is 75years old and her health does not allow to lookafter the children. Her husband is working in Education Department as Lecturer in Distt. Hamirpur. and she is serving at GSSS Lagauti, Distt. Kullu which is about 200 Km away. She has requested that due to adverse family circumstances and couple case, she may kindly be transferred from GSSS Lagauti, Distt. Kullu to GHS Lanjiana/ GSSS Kangoo/ GHS Nalti/GHS Plah Brahmna, Distt.Hamirpur/ GSSS Hatli Distt.Una.

On the perusal of record, it is found that Smt. Pammi Devi, TGT (Arts) is working in GSSS Lagauti, Distt.Kullu since 07.09.2018 and has completed her normal tenure at the present place of posting. As per para 5.4 of the comprehensive Guiding Principles-2013 “ ***In case wife and husband both are working under the State Government efforts be made to post them at one place of near places as far as possible subject to vacancy.***”

In view of facts stated above, representation of petitioner i.e. Smt. Pammi Devi, TGT(Arts) is considered sympathetically and she is hereby transferred from GSSS Lagauti, Distt.Kullu to GHS Lanjiana, Distt.Hamirpur against vacancy being caused due to retirement of present incumbent on 31.3.22, without TTA/JT. The petitioner will join after superannuation of present incumbent.

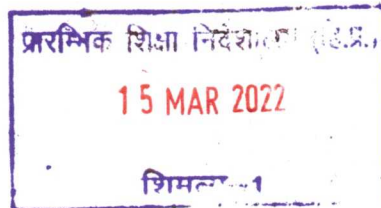
Accordingly representation stands decided.
