Whereas, Shri Shyam Singh, TGT (NM) preferred CWP No. 3392/2023 titled as Shyam Singh Vs. State of H.P. before the Hon'ble High Court of H.P. against his transfer from GMS Agahar u/c GSSS Batot District Chamba to soft area in District Kangra/Chamba. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 01.06.2023 when the Hon'ble High Court has passed the following orders:-

"5. In the given facts and circumstances of the case, we dispose of ths petition, by directing the respondents to consider and decide the case of the petitioner for posting him in a soft area and issue a consequential order of transfers, in accordance with the Transfer Policy by posting the petitioner in any one of the five stations of his choice as mentioned above within a period of four weeks from today. Pending miscellaneous application(s), if any, shall also stand disposed of .For compliance, to come up on 13<sup>th</sup>, July, 2023."

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner has submitted his representation and requested that he may be transfer in the stations nearby his native place against vacancy/longer stayee. The petitioner has also requested to transfer him at GSSS Harchakian, GSSS Padder, GMSSS Kotla, GHS Dodamb Distt. Kangra and GHS Jolna Distt. Chamba against vacancy/longer stayee.

Whereas, from perusal of record, it has been found that the petitioner is working at GMS Agahar u/c GSSS Batot (hard area) District Chamba w.e.f. March, 2019 and has completed three years stay. At present there is no post of TGT(NM) lying vacant in schools given by the petitioner in his representation. One Sh. Kamal Kumar TGT(NM) is working in GHS Jolna, District Chamba since 16-08-2018 and has completed his normal tenure of three years at his present place of posting. He has never served in hard/tribal area. The petitioner has requested in his representation that he may be transferred to GHS Jolna, District Chamba against longer stayee. Keeping in view of the above position, the representation of the petitioner is considered sympathetically and he is hereby transferred from GMS Agahar u/c GSSS Batot (hard area) District Chamba to GHS Jolna, District Chamba vice Sh. Kamal Kumar, TGT(NM) & vice-versa with TTA/JT to Sh. Kamal Kumar, TGT(NM). The representation of the petitioner is disposed of accordingly.
