ORDER

Sh. Sunil Kumar. TGT (Arts) has filed CWP No. 364/2022-before the Hon'ble High Court regarding transfer from GSSS Doghari, Distt.Mandi . The case was listed on 17.02.2022, when the same has been disposed of with the following directions:-

In view of the above, present writ petition is disposed of with a direction to respondent No.2 to decide representation (Annexure P-2) of the petitioner expeditiously, preferably within a period of four weeks. Needless to say, respondents, while doing the needful, shall afford an opportunity of hearing to the petitioner and pass a speaking order thereupon. Liberty is reserved to the petitioner to approach appropriate Court of law, if he still remains aggrieved. Pending applications, if any stand disposed of.

In pursuance to the orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner i.e Sh.Sunil Kumar, TGT(Arts) appeared before the undersigned on dated 18.02.2022. At the time of hearing he has submitted representation vide which he stated that he has rendered 22years of service in Indian Army and has served far flung area of the Country. After retirement from Indian Army he has been appointed as TGT(Arts) and posted in GSSS Doghari, Distt.Mandi which is 200 Km from his native place. He has further requested that he may kindly be transferred from GSSS Doghari (Mandi) to GMS Barchhwar u/c GSSS Nabahi, Distt.Mandi vice Sh. Daljeet Singh, TGT (Arts) /GMS Jamli Plasi u/c GSSS Mundkhar (Hamirpur) /GSSS Mair (Hamirpur)/ GSSS Paplog (Mandi)/ GSSS Maharal (Hamirpur) against vacancy.

On the perusal of record, it is found that Sh. Sunil Kumar, TGT (Arts) is working in GSSS Doghari (Mandi) since 20.6.18 and has completed his normal tenure. Students enrolment is 76 in GSSS Doghari (Mandi) and keeping in view the studies of the students in the said school petitioner can not next be transferred against vacant post. Sh. Daljeet Singh, TGT(Arts) is working in GMS Barchhwar u/c GSSS Nabahi (Mandi) since 14.09.17 and has completed more than four years at the present place of posting.

Keeping in view the submissions made by the petitioner, i.e. Sh. Sunil Kumar, TGT (Arts) is considered sympathetically and he is hereby transferred from GSSS Doghari (MND) to GMS Barchhwar u/c GSSS Nabahi (MND) vice Sh. Daljeet Singh, TGT (Arts) and vice versa with TTA /JT to Sh. Daljeet Singh, TGT (Arts).

Accordingly representation stands decided.
