I am directed to invite your attention to the subject cited above and to say that vide this department letter of even number dated 22-08-2016 the time scheduled/time schedule (issue of first and second advertisement) has been fixed regarding conducting of examination for the posts having same nomenclature and also to reach the requisitions by all Department to the HPSSC, Hamirpur by 28th February and 30th June of each calendar year. It was brought to the notice of the State Government that requisitions are received by the said Commission throughout the year without following the time schedule/time frame as issued vide letter referred to above.
