
ORDER
CWP No. 958/2022 titled as Suresh Kumar,TGT(Med) VS state of
H.P. & others.

The Petitioner Sh. Suresh Kumar filed CWP No. 958/2021 versus State of H.P. before the Hon'ble High Court of H.P. aggrieved her transfer from GSSS Kuthar Beet Distt. Una to GHS Lohgarh Distt. Sirmour. The case of the petitioner was listed before the Hon'ble High Court on 25th Feburary 2022, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

In view of the above ,the writ petition is disposed of requiring the petitioner to approach respondent No.2 the Director of Elementary Education ,Himachal Pradesh,praying for his posting nearby his native place in District Una and respondent No 2 shall pass fresh orders .in conformity with the aforesaid observations,within a perod of fifteen days,from the date of petitioner producing a copy of this order before the said authority.

In compliance to the order/judgement passed by the Hon'ble High Court the petitioner was called for personel hearing on dated 22-03-2022.The petitioner attended the personal hearing on schedule date and time. During personal hearing he has requested that he may be may be adjusted in GSSS Mawa Sindhian /GHS Loharli Distt. Una against longer stayee. The petitioner has further stated that his old age father is suffering from Heart ailment and has undergone by pass surgery. As such there is no one of the family to look after the old age ailing father.

From the perusal of the record, it found that Sh. Suresh Kumar,TGT(Med) has been transferred from GSSS Kuthar Beet Distt. Una to GHS Lohgarh Distt. Sirmour vice Smt. Manoj Kumari,TGT(Med) , on the completion of his normal tenure of three years at his present place of posting. Now, he has joined in his next place of posting on 10-03-2022.However, keeping in view the family circumstances the petitioner is hereby transferred from GHS Lohgarh Distt. Sirmour to GSSS Mawa Sindhian Distt.Una vice Sh. Surjit Singh,TGT(Med) & vice-versa, with TTA/JT to Surjit Singh, TGT(M). With these observations the representation of the petitioner is considered and disposed of accordingly


