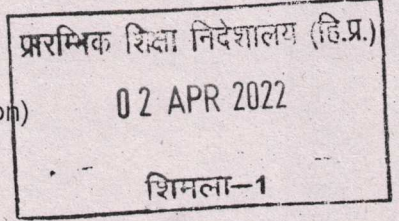



Subject: - Regarding clarification for 5th & 9th class students for providing Food Security Allowance (FSA) under Mid Day Meal Scheme.

Sir

It is stated that the DDEE Solan & Shimla vide their letters No.EDN-SLN(Misc)-2022-22 dated 14.03.2022 and Shiksha Sml (2-4) B(3)4/2010-MDM 42575 dated 17.03.2022 respectively have sought clarification regarding distribution of Food Security Allowance (FSA) to the eligible students under PM Poshan (Mid Day Meal)Scheme in the State. In this context, it is clarified that the students who have passed 5th standard class examination in the month of December 2021 & promoted to 6th standard are entitled to receive per day per child cooking cost of upper primary standard from the schools where they have taken admission in 6th standard for winter vacations period W.e.f.01.01.2022 to 15.02.2022

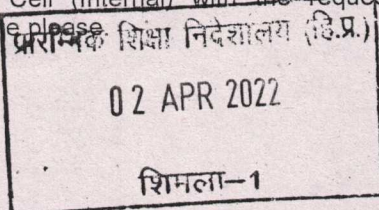
Before providing per day per child cooking cost to the students of 6th standard, it may be ensured that cooking cost to such students have not been provided to them from their previous schools being 5th standard entitlement for winter vacations period. However, the requisite certificate to this effect may be taken from his /her previous schools and the same may be kept in the schools record. In this regard, it is further clarified that the students who have passed the 8th standard examination in December 2021 and taken admission in 9th standard are not entitled for cooking cost for winter vacations w.e.f.01.01.2022 to 15.02.2022 under PM Poshan (Mid Day Meal) Scheme, since the said scheme is only meant for 1st to 8th standard Students as per the mandate of the Scheme .In view of the above, you are therefore requested to take necessary action in the matter under intimation to this office, so as to ensure the distribution of entitled Food Security Allowance(FSA) to the eligible students for the abovesaid vacation period.


