ORDER

Sh. Sanjay Kumar, TGT (Arts) has filed CWP No. 7546/2023-before the Hon'ble High Court of H.P., regarding adjustment who is under orders of transfer GSSSSimni District Chamba to GSSS Chobia, District Chamba. The case was listed on 10-10-2023, when the same has been disposed of with the following orders:-

"Accordingly, the instant petition is disposed of with direction to respondent No. 2 to consider and decide the representation (Annexure P-2), submitted by the petitioner, within a week from today by passing a speaking order. Keeping in view the individual hardship shown by the petitioner, it is ordered that till the final decision on the representation is taken, the impugned transfer order, Annexure P-1, qua the petitioner shall remain stayed. Pending miscellaneous applications(s), if any, also stand disposed of"

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner i.e Sh. Sanjay Kumar, TGT (Arts) has submitted representation and requested that he may be adjusted at GMS Dugar u/c GSSS Pajja, GSSS Chhananu, GSSS Baggi, GSSS Pajja, GSSS Bhunad, GSSS Parihar and GSSS Chuhan, District Chamba, against vacancy, due to his adverse family circumstances.

From the perusal of record, it is revealed that Sh. Sanjay Kumar, TGT (Arts) was transferred from GSSS Simni District Chamba to GSSS Chobia, District Chamba, against vacancy, after completion of normal tenure with the approval of competent authority, where he was working since 14-09-2006 to till date and has completed his normal tenure at his present place of posting. At present two posts of TGT (Arts) are sanctioned in GSSS Bhunad, District Chamba, out of which no TGT (Arts) are working there and 103 students are enrolled in the said school. Keeping in view the position stated above, representation of petitioner i.e Sh. Sanjay Kumar, TGT (Arts) is considered sympathetically and he is hereby adjusted at GSSS Bhunad, District Chamba, against vacancy, without TTA/JT. The representation of the petitioner is disposed of accordingly.
