ORDER

In the matter :

CWP No. 1530/2022-Satbir Singh,TGT(Med) Vs State of H.P. & others (Regarding transfer)

The Petitioner Sh. Satbir Singh,TGT(Med),filed CWP No. 1530/2022 titled as Sh. Satbir Singh versus State of H.P. before the Hon'ble High Court of H.P.regarding his transfer from GHS Koot 15/20 u/c GSSS Ganvi (Rampur Bushahar) Distt. Shimla ,(which fall under hard area) to his choice of station after the completion of required tenure as per policy.The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 21st March,2022, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/order:-

“Having regard to the submission made and without expressing any opinion on the merits of the case,we dispose of this petition with a direction to respondent No.2 to decide the representation in his discretion, in accordance with law,and communicate the decision thereof to the petitioner within a period six weeks from the date a copy of this order is produced before him.”

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated 11-04-2022.The petitioner attended the personal hearing on schedule date and time .During personal hearing he has requested that he may be adjusted in GSSS Ganoh,GHS Raja Ka-ka-Talab,GSSS Aundh,GSSS Bhadwar,GSSS Kopra,Distt. Kangra and GSSS Chowari(CBA) against vacancy or longer stayee.The petitioner has further stated that he is facing some personal difficulties.

From the perusal of the record, it reveals that Sh.Satbir Singh,TGT(Med) has been working in GHS Koot 15/20 u/c GSSS Ganvi (Rampur Bushahar)(Hard area) Distt. Shimla since 13th May.2019 and has completed his normal tenure at present place of posting. Hence keeping in view the family circumstances the petitioner is hereby transferred from GHS Koot 15/20 u/c GSSS Ganvi (Rampur Bushahar) Distt. Shimla to GSSS Ganoh Distt.Kangra,without TTA/JT vice Smt. Seema Sharma,TGT(Med) with TTA/JT.With these observations the representation of the petitioner is considered and disposed of accordingly

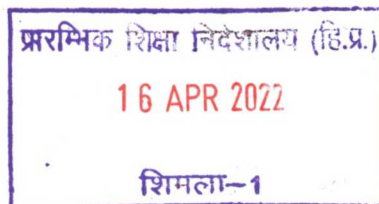
