In the matter of: CWP No. 145/2022 titled as Madan Mohan Vs. State of H.P. & Others.

Whereas, Shri Madan Mohan, TGT (NM) preferred CWP No. 145/2022 titled as Madan Mohan Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Kutgarh District Mandi (Hard Area) to District Kangra/Mandi in soft area. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 5.1.2022 when the Hon'ble High Court has passed the following orders:-

" 3. Accordingly, without adverting to the merits of the case, this writ petition is disposed of by giving liberty to the petitioner to approach respondent No. 2 by making a fresh representation, in terms of transfer policy dated 10.7.2013, within a week from today and in case the petitioner moves such representation, then respondent No. 2 is directed to consider and dispose of the same, in accordance with law, within two weeks from the date of receipt of the same alongwith a copy of this order. Pending application(s), if any, also stand disposed of."

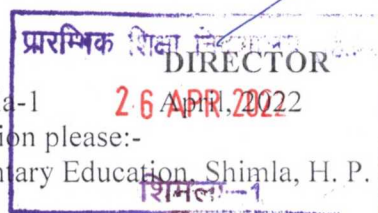
In the compliance of the aforesaid orders passed by the Hon'ble High Court, the petitioner submitted his representation in this office on 10.1.2022 and he requested to transfer/adjust him in the station of his choice as he has completed three years stay in hard/sub-cadre area against vacancy/longer stayee.

From perusal of record, it has been found that the petitioner is working in GSSS Kutgarh District Mandi since 29.07.2017 and has completed more than three years stay there. The petitioner is working in hard/sub-cadre area of Mandi District and is entitled for transfer at the station of his choice as per policy. The petitioner has given five stations of his choice in which four of District Mandi and one of District Kangra. One Sh. Pawan Kumar, TGT(NM) is working in GSSS Galoo District Mandi since 19.9.2017 and has completed more than four years stay at his present place of posting. He has never served in hard/tribal area. Keeping in view of the position stated above, the petitioner is hereby transferred from GSSS Kutgarh District Mandi to GSSS Galoo District Mandi & vice-versa, with TTA/JT to Shri Pawan Kumar, TGT(NM). The representation of the petitioner is disposed of accordingly.
