Whereas, Sh. Virender Kumar, TGT(NM) has preferred CWP No. 9785/2023 titled as Virender Kumar Vs. State of H.P. before the Hon'ble High Court against his transfer from GSSS Dhaloon, Distt. Kangra to GHS Shour, U/C GSSS Purthi, Distt. Chamba which is a hard/sub-cadre area. The above writ petition was listed before the Hon'ble High Court, H.P on 12-12-2023 when the Hon'ble High Court has passed the following orders:-

*"9. In the entirety of the facts referred to above, this court permits the petitioner to ventilate his grievances by moving a representation before the Respondent No. 2- Director Elementary Education, H.P, within three days from today, with further directions to the aforesaid respondent to consider/examine the same and pass appropriate orders, in the light of clause 12,15 & 16 of the transfer policy after giving a personal hearing to the petitioner, within two weeks from today."*

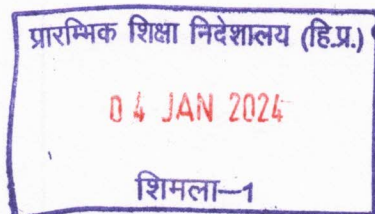
In compliance of the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 04-01-2024. He attended the same and submitted his representation in this office on 20-11-2023, vide which he has requested that he may be adjusted nearby in Distt. Kangra, against vacancy/ longer stayee.

Whereas, from the perusal of record, it has been found that the petitioner has already served at GSSS Dugli, Distt. Chamba w.e.f. 04-06-2009 to 14-11-2014 which was the hard/Remote/Tribal area. Keeping in view of the position stated above, the request of the petitioner is considered sympathically and petitioner sh. Virender Kumar who is under transfer from GSSS Dhaloon, Distt. Kangra to GHS Shour, U/C GSSS Purthi, Distt. Chamba is hereby adjusted without TTA/JT at GSSS (Girls) Dharamshala, Distt. Kangra against vacancy. The representation of the petitioner is disposed of accordingly.
