In the matter of: CWP No. 9723/2023 -titled as Surinder Paul, Vs. State of H.P. & Others.

Whereas, Sh. Surinder Paul, TGT (NM) preferred CWP No. 9723/2023 titled as Surinder Paul, TGT(NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GSSS Lakadhar, Distt. Shimla to nearby home station in Distt. Kangra/Chamba. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 04-12-2023 when the Hon'ble High Court has passed the following orders:-

*"8. In the above facts and circumstances, as referred to above, this court permits the petitioner to make a fresh representation, within a week from today, in continuation to the earlier representation dated 03-08-2023 with directions to respondent No.2-Director the representation dated 03.08.2023, Annexure P-1, alongwith the additional representation, indicating one additional station of choice, as referred to above, within two weeks thereafter, in consonance with Clauses 12 and 16 of the Transfer Policy and to pass appropriate orders, within four weeks".*

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 04-01-2024. He attended the same and submitted her representation in this office on 04-01-2024, vide which he has requested that he has completed required tenure at his present place of posting and he further requested that he may be transferred to nearby home station in Distt. Kangra, against vacancy/ longer stayee, being couple case.

Whereas, from perusal of record, it has been found that the petitioner is working at GSSS Lakadhar, Distt. Shimla, w.e.f. 20-11-2019 and has completed three years stay at present place of posting. Petitioner is a TGT (NM) which is a state cadre post and can be transferred anywhere in the state as per requirement. One Sh. Uppinder Singh, TGT(NM) is working in GSSS Gagahar, Distt. Chamba since 21-02-2017. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and he is hereby transferred without TTA from GSSS Lakadhar, Distt. Shimla to GSSS Gagahar, Distt. Chamba, vice Sh. Uppinder Singh, TGT(NM), against longer stayee, with TTA/JT to Sh. Uppinder Singh, TGT(NM). The representation of the petitioner is disposed of accordingly.



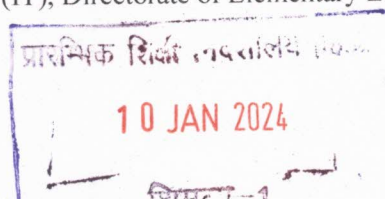
