Whereas, Smt. Banita Kumari, TGT (NM) preferred CWP No. 9509/2023 titled as Banita Kumari Vs. State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GMS Kotla u/c GSSS Galani District Shimla to the station nearby her native place Distt. Hamirpur against vacancy/ longer Stayee. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 29.11.2023 when the Hon'ble High Court has passed the following orders:-

" 7. Accordingly, this Court directs Respondent No. 2-Director of Elementary Education, Himachal Pradesh, to consider/examine the representation dated 06.07.2023 (Annexure P-1), after affording a personal hearing to the petitioner, within two weeks from today.

As aforesaid, the instant writ petition, as well as, the pending miscellaneous application(s), if any, shall also stand disposed of, accordingly."

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 04-01-2024. She has attended the same and submitted her representation in this office on 04-01-2024 vide which she has requested that she has completed required tenure at her present place of posting i.e GMS Kotla u/c GSSS Galani District Shimla, H.P and she further requested that she may be transferred to Distt. Hamirpur, against vacancy/ longer stayee by clubbing his/her previous stay. Petitioner has given five stations of her choice in District Hamirpur.

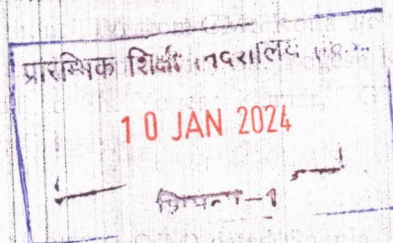
Whereas, from perusal of record, it has been found that the petitioner is working at GMS Kotla u/c GSSS Galani District Shimla w.e.f. 06.02.2020 and has completed more than three years stay at present place of posting. One Sh. Yogesh Kumar TGT (NM) is working in GMS Ukhli u/c GSSS Mair, Distt. Hamirpur since 23.11.2021. The petitioner has given willingness for her transfer to the aforesaid school against longer stay. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and she is hereby transferred without TTA from GMS Kotla u/c GSSS Galani, Distt. Shimla to GMS Ukhli u/c GSSS Mair, Distt. Hamirpur, vice Sh. Yogesh Kumar, TGT (NM) by clubbing his previous stay, with TTA/JT to Sh. Yogesh Kumar, TGT (NM). The representation of the petitioner is disposed of accordingly.
