(Regarding Transfer)

ORDER

Sh. Sushil Kumar, TGT (Arts) has filed CWP No. 1606/2022-before the Hon'ble High Court of H.P. regarding his transfer from GSSS Khabal Distt. Shimla to District Kangra in his home district. The case was listed on 22-03-2022, when the same has been disposed of with the following directions:-

.....3. "Accordingly, without adverting to the merits of the case, this writ petition is disposed of with a direction that in case the petitioner moves a fresh representation to the respondents in terms of the transfer policy, dated 10th July, 2013, within a week from today, then respondents shall dispose of the same within two weeks of the receipt of the representation, in accordance with law. Pending application(s), if any, also stand disposed of."

In pursuance to the orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner i.e. Sh. Sushil Kumar, TGT (Arts) was called for personal hearing and he appeared before the undersigned on 19-04-2022. At the time of personal hearing he has submitted representation in which he requested that he is working in GSSS Khabal since 05-05-2017 which is sub-cadre of District Shimla. He has further requested that he may kindly be transferred from GSSS Khabal District Shimla to GSSS Gurial/GSSS Golwan/GSSS Ganoh/GSSS Dhaneti/GMS Tarala u/c GSSS Ganoh, District Kangra or GMS Basa u/c GSSS Hatli District Chamba.

On the perusal of record, it is found that petitioner i.e. Sh. Sushil Kumar, TGT (Arts) is working in GSSS Khabal Distt. Shimla (which is in sub-cadre) since 05-05-2017 and has completed his normal tenure at present place of posting. At present posts of TGT (Arts) are not lying vacant in the above mentioned schools. However, one Sh. Ajay Bhushan, TGT (Arts) is working in GMS Basa u/c GSSS Hatli (Chamba) since 04-09-2018 and has completed his normal tenure at the present place of posting.

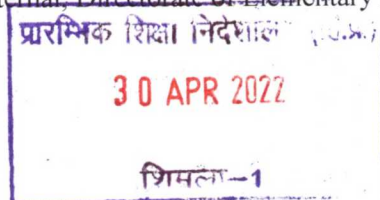
Keeping in view of the position stated above, representation of petitioner i.e. Sh. Sushil Kumar, TGT (Arts) is considered sympathetically and he is hereby adjusted at GMS Basa u/c GSSS Hatli Distt. Chamba vice Sh. Ajay Bhushan, TGT (Arts) who is further transferred to GSSS Khabal Distt. Shimla with TTA/JT to Sh. Ajay Bhushan, TGT (Arts).

Accordingly representation stands decided.
