5. The incumbent (s) who has/have not completed three years tenure in his/her present place of posting transfer orders may not be implemented, if otherwise stay of the incumbent (s) not condoned.
6. All provisions as contained in O/M No:PER (AP-3) E(3)17/2021 dated 10.07.2013 "Comprehensive Guiding Principles 2013---- for regulating the transfer of State Govt. Employees at point No.5" concession to certain categories of employees and 5.5. of O/M dated 17.9.15 must be adhered strictly.
