**In the matter :** CWP No.4349/ 2022 titled as Avinash Thakur,TGT(Med)VS State of H.P. & others.

The Petitioner,Sh. Avinash Thakur TGT(Med), filed CWP No. 4349/2022 titled as, Avinash Thakur,TGT(Med), versus State of H.P. before the Hon'ble High Court of H.P.regarding his transfer from GSSS Baga Chanogi Thach Distt. Mandi ((which fall under hard/Tribal area) to his choice of station after the completion of required tenure as per policy.The case of the petitioner was listed before the Hon'ble High Court, on 04<sup>th</sup> July,2022, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions / order:

*"In view of the above,we deem it appropriate to dispose of the instant writ petition by directing the resopondents/competent authority to consider and decide the aforesaid representation (Annexxure P-3) in accordance with law and issue consequential orders of transfer of the petitioner to anyone of the aforesaid stations,within a period of three weeks from today.*

*The writ petition stands disposed of the above terms,so also the pending miscellaneous applications,if any."*

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated 25-07-2022.The petitioner attended the personal hearing on scheduled date and time. During personal hearing, he has requested that he may be adjusted GSSS Barsar/GHS Dhirwin,GSSS Smaila, GHS Kheri Distt. Hamirpur and GSSS Sarkaghat Dsitt. Mandi against vacancy due to promotion of present.

The Petitioner Smt. Sarla Devi, TGT(Med), filed CWP No. 4508/2022 titled as, Sarla, TGT(Med), versus State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GHS Shala Nishar u/c GSSS Thalou Distt. Mandi to her choice of station after the completion of required tenure as per policy. The case of the petitioner was listed before the Hon'ble High Court, on 08<sup>th</sup> July, 2022, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions / order:

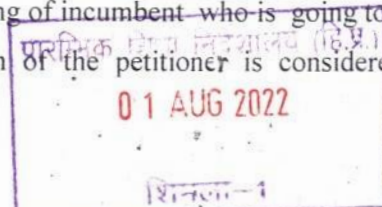
*"The petitioner is seeking her transfer. The learned counsel for the petitioner has pointed out that the petitioner has already made a representation dated 21-06-2022 (Annexure P-5). The learned counsel for the petitioner further states that the petitioner would be satisfied if the aforesaid representation is decided.*

*Hence, we dispose of the petition by directing respondent No.2, the Director of Higher Education, Himachal Pradesh, to decide the representation of the petitioner expeditiously and in any event within three weeks from today.*
