In the matter of: CWP No. 6495/2021 titled as Radhe Sham Vs. State of H.P. & Others.


Whereas, Sh. Radhe Sham, TGT (NM) preferred CWP No. 6495/2021-titled as Radhe Sham Vs. State of H.P., before the Hon'ble High Court of H.P. regarding his transfer from Govt. Sr. Sechondary School Nangal District Kangra to Govt. Middle School Charang u/c Govt. High School Thangi District Kinnaur. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 20.10.2021 when the Hon'ble High Court has passed the following orders:-

"...6. In view of the aforesaid submissions made by learned counsel for the petitioner and without examining the merits of the case, we set the petitioner at liberty to make a comprehensive representation to respondent No. 2- the Director of Elementary Education, Hmachal Pradesh, raising his grievances, who shall decide the same, in accordance with the policy, under intimation to the petitioner, within a period of fifteen days from from the date of submissions thereof alongiwth a copy of this order.

7. The writ petition is disposed of accordingly, so also the pending miscellaneous application(s), if any"

In compliance to the directions of the Hon'ble High Court the petitioner submitted his representation in this Directorate on 25.10.2021. He was called for personal hearing on 12.11.2021 and he attended the same. He requested that he may kindly be adjusted at GSSS Hobar/GMS Bagori u/c GSSS Kiani District Chamba against vacancy due to his adverse family circumstances.

From perusal of record, it has been found that the petitioner has been transferred from from Govt. Sr. Sechondary School Nangal District Kangra to Govt. Middle School Charang u/c Govt. High School Thangi District Kinnaur vice Shri Vijay Kumar, TGT(NM) & vice-versa in view of CWP No. CWP. No. 4507/2021-titled as Vijay Kumar, TGT (NM) Vs. State of H.P. & Others vide this office order of even number dated 15.9.2021. The petitioner stated in his representation that his wife is working as Patwari in Revnew Department at Patwar Circle Badla Tehsil Fatehpur District Kangra and his son is studing in 12th Class and his daughter is studing in 10th Class which are both the Board Classes. Keeping in view of the above position the petitioner is hereby adjusted at Govt. Middle School Bagori u/c GSSS Kiani District Chamba against vacancy, without TTA/JT, on his own request. The representation of the petitioner is disposed of accordingly.
