Subject:- LPG subsidy to schools with Unified District Information System for Education (U-DISE) number – reg

Sir/Madam,

The Government of India ,Ministry of Human Resource Development Department of School Education & Literacy New Delhi vide letter No.1-1/2016-Desk (MDM) dated 24th January , 2017 has informed the State that the GOI ,MHRD had taken up the matter with the Ministry of Petroleum & Natural Gas to provide LPG to the rates applicable to the domestic consumers and to exempt the schools from Aadhar seeding for availing the subsidy into the accounts of the schools. In this context, the Ministry of Petroleum & Natural Gas now informed vide letter No.P-23015/7/2013-LPG dated 11th January, 2017 (copy enclosed) that Oil Companies have already been advised to treat schools under Mid Day Meal under the category at Non-Domestic exempt category (NDEC) . LPG connections to NDEC is to be provided at par with the domestic consumers who are admissible for availing subsidy up to admissible cap on LPG cylinders for domestic consumers. The Ministry of Petroleum and Natural Gas has further informed that Oil Companies have further been instructed to exempt from seeding account of NDEC customers with Aadhar Numbers and to transfer LPG subsidy to their bank account through Bank Transfer Compliant modes. The Ministry has further issued instructions to link LPG subsidy to schools with Unified District information System for Education (U-DISE) number.

In view of the above, it is, therefore, requested that the above instructions of the Ministry of Petroleum & Natural Gas may be circulated to all the implementing agencies and schools to enable them to avail the subsidy on LPG cylinders under MDMS by linking their U-DISE number with the bank account.


