NOTIFICATION

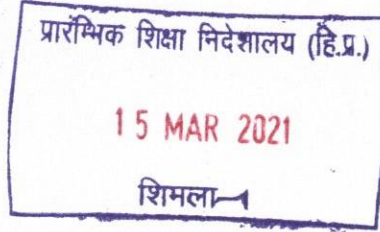
