

Regarding supply & installation of AEBAS devices in 4474 G.P.S. Subject: and stand alone G.M.S. of H.P. in 1^{ST} PHASE- instructions thereof.

It is in continuation to this office letter no. even dated 20-12-17, 01-06-18, 16-01-18 and 12-09-2019 on the subject cited above. Vide these letters a list of 4474 schools (GPS & Standalone GMS) was circulated where Aadhaar Enabled Biometric Attendance System (AEBAS) devices are to be installed in 1st phase.

- 1) All the DDEE's were requested to duly and on record nominate one Distt. Nodal Officer (DNO-AEBAS) for the purpose.
- 2) All the DDEE's & BEEO's (BNO-AEBAS) were also directed to upload the record of all the employees of schools (GPS & Standalone GMS) falling under their jurisdiction on the 'hpdeesml.attendance.gov.in/auth/login' portal using the supplied password.
- 3) All the concerned 4474 schools were asked to purchase GSM-SIM cards (4G) -JIO/BSNL/AIRTEL (best signal strength service provider) and activate NET data service for 1 year on it as per rate quotations supplied involving SMC actively in the process.
- 4) All the BEEO's were asked to act as BNO-AEBAS himself/herself OR duly nominate any other official as BNO in this matter and report to DDEE . 1 | 10 |

Now,

- A) The proper list of DNO-AEBAS and BNO-AEBAS must be sent by all the distt. DDEE's to this office (soft copy in shape of e-mail on Excel sheet) before 21-10-2019 without fail, clearly mentioning name, designation, contact number (preferably whats app no.) and e-mail ld of the official so nominated.
- B) Distt. DDEE's/DNO's will report the status (as on 21-10-2019) of registration/uploading/updating the relevant data of all the employees of all the GPS/GCPS/standalone GMS on the attendance portal of the deptt. as laid in the format (annexure-D) by 22-10-2019 in soft copy.
- C) Distt. DDEE's/DNO's will also report the status (as on 25-10-2019) of purchasing & submission of data service activated GSM-SIM with BNO, by the GPS/GCPS/standalone GMS falling in the said list of 4474 schools as laid in the format (annexure-E) by 26-10-2019 in soft copy.

These instructions must be treated as time-bound.

The process of supply of AEBAS machines will start within 10 days. All the BEEOs are directed to update all employees bio-data of all schools (GPS & Standalone GMS, If not done earlier) immediately but before 21-10-19. Now, all the DDEE's & BEEO's of all the districts / blocks will be responsible to carry out the process of receipt / activation / installation / usage / functioning and proper maintenance of AEBAS machines under their control. It shall also apply for the AEBAS machines already installed / un-installed, activated / not activated in their own offices also.

Roles and responsibilities of officers/officials at different levels shall be as detailed below:-

- 1. All the AEBAS machines will be received by DDEEs (DNO-AEBAS) and kept in his/her safe custody till further movement to the concerned schools. The date of activation of machines will be fixed by DNO-AEBAS block wise after consultation with company (QUALITY INDUSTRIAL CORPORATION 119-C Gobind Nagar, Ambala Cantt., Haryana 133001) officials and BNO-AEBAS but within 7 days of machines arrival. Machines come under warranty period of 3 years without coverage for physical damage. Receipt report may be sent by DNO to this directorate.
- 2. AEBAS machines will be activated at the concerned DDEE office. Activation process will be done by the company officials in the presence of concerned DNO-AEBAS and BNO-AEBAS. The BEEO's will arrange to collect all the GSM service activated (charged) -SIM cards from the concerned primary schools as well as stand alone middle schools as per list well before the date fixed for activation by the DNO. BNO-will ensure submission of so collected SIM's from all the

- concerned schools falling under their block in the O/O DDEE for activation of machines.
- 3. GSM-SIMS needs to be activated and NET data service activated for one year by each school listed for installation of AEBAS before submission to BEEO office. The head / in- charge of that school shall be accountable for this process. The payment for SIM network charging may be done from the SSA/ RMSA/ SMC funds or by the DDO from O.E. Proper bill vouchers/ resolutions of SMC/ codal formalities should be done and documents be made available for audit as and when required.
- 4. After activation at O/O DDEE Company officials will install the machines in individual schools at a safest place near the 5 Amp electric socket point preferably in the O/O Head/ incharge of school. It will be the sole responsibility of the head / incharge of school to keep the machine power plugged ON and its safe custody 24*7. Stock entry should be made in the school records. After installation, certificates are to be furnished by the respective authorities as in attached annexures. Training to all the DNO's / BNO's / teachers / officials of school shall be imparted on the spot by the company officials.
- 5. In case of any complaint regarding AEBAS or non functioning of machine the head / incharge of school will immediately intimate BNO-AEBAS through SMS and in paper. It should be done promptly as and when any sang is noticed. BNO-AEBAS will report the complaints promptly to DNO-AEBAS re-forwarding the SMS and in paper also. DNO-AEBAS will report the complaints to the company on daily basis via online or SMS. Proper record of working of machines and complaints be maintained in a separate register at school / block and Distt. level by the concerned officials. If the complaint remains un-addressed by the company for more than 2 working days, the DNO shall bring the matter into the notice of SNO / Directorate. Each minor happening should be detailed in the register.
 - The traditional manual attendance system will be kept continued as a backup till further instructions. The inspecting authorities visiting the school will check manual attendance register as well as AEBAS device report. Both the attendance records particularly entries of time [arrival & departure] should match.
- 6. In future recharging of data service of SIMs should be done before hand by the head. It shall be better, if expiry date of present NET data service be pasted near the device. The machine should be kept operational and instructions passed by the technical experts should be adhered to by the head and all the staff members of school. SMC should be actively involved in the matter / process at all levels. All type of quires may be addressed through the proper channels.
- 7. In future BEEO's/BNO's will update the data of employees of GPS/standalone GMS under their area on the attendance portal in case of retirements/ transfers/

promotions/ posting/ up-gradation & opening of new schools effected under

8. In future DNO's, BNO's and concerned school heads will be solely responsible & accountable for proper receipt, activation, installation, functioning, maintenance & timely reporting regarding AEBAS machines.
