NOTIFICATION

In exercise of the powers conferred by clause (3) of article 166 of the Constitution of India, the Governor, Himachal Pradesh, is pleased to make the following rules further to amend the Business of the Government of Himachal Pradesh (Allocation) Rules, 1971, notified vide Notification No. 5-2/71-GAD(CC) dated 25th January, 1971, namely:-

Short title and commencement.

1. (1) These rules may be called the Business of the Government of Himachal Pradesh (Allocation) 159th Amendment Rules, 2020.

(2) These rules shall come into force from the date of their publication in the Rajpatra (e-Gazette), Himachal Pradesh.

Amendment of SCHEDULE

2. In the SCHEDULE appended to the Business of the Government of Himachal Pradesh (Allocation) Rules, 1971, at S. No. 18, wherever occurs for the words "IRRIGATION AND PUBLIC HEALTH DEPARTMENT", the following shall be substituted, namely:-

"JAL SHAKTI VIBHAG."
