In the matter of: CWP No. 1505/2022 titled as Surinder Kumar Vs. State of H.P. & Others.

Sh. Surinder Kumar, TGT (NM) preferred CWP No. 1505/2022 titled as Surinder Kumar, TGT(NM) Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from Reckong Peo District Kinnaur(hard/tribal area) to his home District i.e. Kangra District. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 17.3.2022 when the Hon'ble High Court has passed the following orders:-

" 4. Accordingly, without advertng to the merit of the case, we dispose of the writ petition with a direction that in case the petitioner moves fresh representation before respondent No. 2, Director of Elementary Education, in terms of the Transfer Policy dated 10.7.2013, within one week from today, the same shall be disposed of by respondent No. 2, in accordance with law, within two weeks thereafter from the date of the receipt of the representation alongwith copy of this order.

5. Pending miscellaneous application(s), if any, shall also stand disposed of."

In the compliance of the aforesaid orders passed by the Hon'ble High Court, the petitioner has submitted his representation in this office on 24.3.2022 vide which he has stated that he may be adjusted at his home. The petitioner has given another representation dated 19.5.2022 in this office vide which he requested that he may be adjusted at GSSS Sanhoon Distt. Kangra.

From perusal of record, it has been found that the petitioner is working in GSSS Reckong Peo District Kangra since 4.9.2018 and has completed more than three years stay at his present place of posting. One post of TGT(NM) is being caused vacant due to promotion of present incumbent in Govt. Sr. Sec. School Sanhoon District Kangra. Keeping in view the above facts and circumstances the representation of the petitioner is considered sympathetically he is hereby transferred on his own request from GSSS Reckong Peo District Kinnaur to Govt. Sr. Sec. School Sanhoon District Kangra against vacancy being caused due to promotion of present incumbent in near future. These orders will be implemented after the relieving of the present incumbent on promotion. The representation of the petitioner is disposed of accordingly.
