In the matter : CWP No.4273/ 2022 titled as Arun Kumar,TGT(Med)VS State of H.P. & others.

The Petitioner,Sh.Arun Kumar, TGT(Med), filed CWP No. 4273/2022 titled as, Arun Kumar,TGT(Med), versus State of H.P. before the Hon'ble High Court of H.P.regarding his transfer from GSSS Goushal (Keylong), (Which fall under hard/Tribal area) Distt. Lahul Spiti to his choice of station after the completion of required tenure as per policy.The case of the petitioner was listed before the Hon'ble High Court, on 01st July,2022, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions / order:

" The only substantive prayer in the writ petition is prayer Clause(a),which reads as follows:

(a) The respondent No.2 may kindly be directed to decide the representation of the petitioner i.e. Annexure(P-1) within in time bound manner or the petitioner may kindly be transferred in any above mentioned station "

We accordingly,direct respondent No.2-Director of Elementary Education,Himachal Pradesh,to decide the representation of the petitioner dated 04-04-2022(Annexure P-1)) expeditiously and in any event within three weeks from today. "

The petition to stand disposed of in the aforesaid terms,so also pending miscellaneous application(s),if any."

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated 25-07-2022.The petitioner attended the personal hearing on scheduled date and time. During personal hearing the petitioner has requested that he may be adjusted in GSSS Kais/GSSS Jindour/GMSSS Manali/ GSSS Mohal /GSSS Hallan-1 Distt. Kullu against vacancy due to promotion of present incumbent. He also stated that his wife is also working as TGT(Med) in GSSS Raison Distt. Kullu.

From the perusal of the record, it reveals that Sh. Arun Kumar,TGT (Med), has been working in GSSS Goushal(Keylong) Distt. Lahul Spiti, (which fall under hard area) since 07th Oct.2017, has completed his normal tenure at present place of posting. Hence ,the representation of the petitioner is considered sympathetically and he is hereby transferred from GSSS Goushal (Keylong) Distt. Lahul Spiti to GSSS Hallan-I Distt. Kullu against vacancy being caused due to promotion of present incumbent .These orders will be implemented after the relieving of incumbent who is going to be promoted. With these observations the representation of the petitioner is considered and disposed of accordingly.

Smt.Rashmi Sharma,TGT(Med) has filed CWP No. 4403/2022 titled as Rashmi Sharma,TGT(M) versus State of H.P. before the Hon'ble High Court of H.P.regarding her transfer from GSSS Raipur Chowari Distt. Chamba. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 05th July,2022, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

"Learned counsel for the petitioner states that the petitioner would be satisfied if her representation(Annexure P-2)) pending,before respondent No.2 is considered and decided,in accordance with law.

In view of the aforesaid statement,we dispose of the writ petition by directing respondent No.2 to consider and decide the representation of the petitioner(Annexure P-2) expeditiously and in any event within two weeks from today"

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated 25-07-2022. The petitioner attended the personal hearing on scheduled date and time. During personal hearing, she has requested that she may be adjusted in GSSS Joginder Nagar (MND),GHS Thandol,GSSS Sullah,GSSS Averi, GSSS Salehra, GSSS Pandol Distt. Kangra against vacancy casued due to promotion of present incumbent.The petitioner has further stated that her mother -in-law is 100% bed ridden and is patient of Alzheimer and there is no one in the family to look after the old and ailing mother -in -law.

From the perusal of record, it reveals that the petitioner has been working in GSSS Raipur Chowari Distt. Chamba since 18th Nov.2019, has not completed her normal tenure at present place of posting. Hence, keeping in view the family circumstances the representation of the petitioner is considered sympathetically and she is hereby transferred from GSSS Raipur Chowari Distt. Chamba to GSSS Sullah Distt. Kangra against vacancy being casued due to promotion of present incumbent.These orders will be implemented after the relieving of incumbent who is going to be promoted. With these observations the representation of the petitioner is considered and disposed of accordingly.
