

**ORDER**

In the matter of: CWP No: 8090/2022-titled as Sunil Kumar Vs. State of Himachal Pradesh  
(Regarding Transfer).

Sh. Sunil Kumar, TGT(Arts) has filed CWP No. 8090/2022-before the Hon'ble High Court of H.P. regarding transfer from GMS Charang u/c GHS Thangi, Distt. Kinnaur. The case was listed on 16.11.2022, when the same has been disposed of with the following orders :-

*The petitioner has completed his normal tenure of service in a tribal area at Govt. Middle School Charang u/c Govt. High School Thangi, District Kinnaur, since his initial appointment w.e.f 18.11.2019. Therefore, he is entitled to be transferred from the tribal area to a soft area, that too a station of his choice, in terms of the transfer policy/guidelines framed by the Government in this regard. The petitioner has given five stations of his choice in paragraph-7 of the instant petition, which are enumerated as under:-*

- i) Govt. Middle School Sohra Biuns u/c Govt. High Schools Sai Brahmna, Tehsil Sadar, District Bilaspur.
- ii) Govt. Middle School Pipal Ghat u/c Govt. Sr.Sec.School Chakoh, Tehsil Sader, District Bilaspur.
- iii) Govt.Sr.Sec.School Barmana, Tehsil Sadar, District Bilaspur.
- iv) Govt. Sr. Sec. School Dhar Tatoh, Tehsil Sadar. District Bilaspur.
- v) Govt. Sr.Sec.School Dehar Block Sunder Nagar, District Mandi.

*In this view of the matter, we dispose of the petition with a direction to the respondents State to consider the case of the petitioner and thereafter issue consequential orders of transfer to any one of the stations of his choice within a period of three weeks from today. Pending application (s), if any, also stand disposed of.*

*For compliance, to come up on 13<sup>th</sup> December, 2022."*

In compliance to the aforesaid order/ judgment passed by the Hon'ble High Court of Himachal Pradesh, the representation filed by the petitioner was perused and found that Sh. Sunil Kumar, TGT (Arts) was appointed as TGT (Arts) on 18.11.19 and posted in GMS Charang u/c GHS Thangi, District Kinnaur. At present he is working on deputation basis at GSSS Reckong Peo, District Kinnaur due to zero enrolment in GMS Charang u/c GHS Thangi, Distt. Kinnaur. Keeping in view the position stated above, representation of petitioner i.e Sh. Sunil Kumar, TGT(Arts) is considered sympathetically and he is hereby adjusted at GMS Sohra Biuns u/c GHS Sai Brahmna, District Bilaspur, against vacancy. The representation of the petitioner is disposed of accordingly.
