ORDER

In the matter of: CWP No. 7508/2022 titled as Suman Kumari Vs. State of H.P. & Others.

Whereas, Smt. Suman Kumari, TGT (NM) preferred CWP No. 7508/2022 titled as Suman Kumari Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Luhri District Kullu to the station nearby his native place. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 27.10.2022 when the Hon'ble High Court has passed the following orders:-

" 3. Accordingly, without adverting to the merits of the case we deem it appropriate to dispose of the writ petition with a direction to respondent No. 2, Director of Elementary Education, to dispose of the representation Annexure P-2, moved by the petitioner, in accordance with law, within a period of two weeks from the date of receipt of the copy of the order."

Whereas, stations given by the petitioner in his representation dated 19.11.2022 vide which she has requested to transfer her from GSSS Luhri District Kullu to the stations near to her native place i.e. GSSS Kalruhi/GSSS Gondpur Banehra/GHS Harot/GSSS Saloh/GSSS Jakhera/GHS Channi/GMS Lot u/c GSSS Uttarala District Kangra against vacancy.

From perusal of record, it has been found that the petitioner has been working at GSSS Luhri District Kullu w.e.f. 12.03.2019 and has completed more than three years stay. At present one post of TGT(NM) is lying vacant in GMS Lot u/c GSSS Uttarala District Kangra. Keeping in view, the above facts and circumstances, the case of the petitioner for transfer is considered sympathetically and she is hereby transferred without TTA/JT from GSSS Luhri Distt Kullu to GMS Lot u/c GSSS Uttarala District Kangra against vacancy. The representation of the petitioner is disposed of accordingly.
