Maternity Leave benefits to women Cook-cum-Helpers engaged under PM Poshan Scheme in Schools under Maternity Benefits Act, 1961.

Sir,

I am directed to refer to your letter No. EDN-H(EE)(6)4-9/2020-21-MDM Policy dated 06-06-2023 on the subject cited above and to convey herewith the approval of the Government to amend Clause 19b & condition No. 3 of Anexure-I (agreement to be executed between SMC and CCH) of the Guidelines for engagement of Cook-cum-Helpers under PM Poshan Scheme as under:-

Continuous absence beyond three days from the school without approval of member secretary/ competent authority shall automatically lead to the termination of the services of the Cook-cum-Helper. The Cook-cm-Helper will not be entitled for any wages/ remuneration for the period of absence. However, the female Cook-cum-Helper with less than two surviving children may be granted Maternity Leave for 180 days under Maternity Benefit Act, 1962.

Condition No. 3 of Annexure-I:-

3. That he/she shall employ himself/herself efficiently and diligently and to the best of his/her ability as Cook-cum-Helper and that he/she shall devote his/her time to the duties of the service and that he/she shall not absent himself from his/her said duties without having obtained prior permission from the immediate officer. The Cook-cum-Helpers will not be entitled to any remmeration for the period of absence. However, the female Cookcum-Helper with less than two surviving children may be granted Maternity Leave for 180 days under Maternity Benefit Act, 1962.

You are, therefore, requested to take further necessary action in the matter accordingly.
