Whereas, Smt. Vishakha, TGT (NM) preferred CWP No. 559/2024 titled as Vishakha Vs. State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GSSS Samleu District Chamba to the station nearby her native place Distt. Kangra, against vacancy/ longer Stayee. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 12.01.2024 when the Hon'ble High Court has passed the following orders:-

"7. In the entirety of the facts and circumstances referred to above, the instant writ petition, is disposed of, with direction to the Respondent No. 2- Director of Elementary education, Himachal Pradesh, Shimla, to consider/examine the representation dated 09.10.2023 (Annexure P-2), and to pass appropriate orders thereon, in accordance with law, after affording a personal hearing, to the petitioner, within four weeks from today.

As aforesaid, the instant writ petition as well as the pending miscellaneous applications, if any, also stand disposed of, accordingly."

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 03.02.2024. She has attended the same and submitted her representation in this office on 03.02.2024 vide which she has requested that she has completed required tenure at her present place of posting i.e GSSS Samleu District Chamba, H.P and she further requested that she may be transferred to Distt. Kangra, against vacancy/longer stayee by clubbing his/her previous stay. Petitioner has given five stations of her choice in District Kangra.

Whereas, from perusal of record, it has been found that the petitioner is working at GSSS Samleu District Chamba w.e.f. 15.09.2017 and has completed more than three years at present place of posting. One Sh. Opinder Singh Guleria TGT (NM) is working in GSSS Mohtali, Distt. Kangra since 12.11.2021. The petitioner has given willingness for her transfer to the aforesaid school against longer stay by clubbing his previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and she is hereby transferred without TTA from GSSS Samleu District Chamba to GSSS Mohtali, Distt. Kangra, vice Sh. Opinder Singh Guleria, TGT (NM) against longer stay by clubbing his previous stay within radius of 30 Kms with TTA/JT to Sh. Opinder Singh Guleria, TGT (NM). The representation of the petitioner is disposed of accordingly.
