Whereas, Smt. Niranjana Kaur, TGT (NM) preferred CWP No. 439/2024 titled as Niranjana Kaur, TGT(NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding transfer from GSSS Badgran, Distt. Chamba to nearby home station in Distt. Kangra. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 11-01-2024 when the Hon'ble High Court has passed the following orders:-

" 2. In view of the aforesaid facts and attending circumstances, the petitioner is free to pursue the representation before the concerned authority in accordance with law and same is disposed of, so also, pending miscellaneous applications, if any."

In the compliance the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 03-02-2024. She attended the same and submitted her representation in this office on 03-02-2024, vide which She has requested that She has completed required tenure at her present place of posting and She further requested that She may be transferred to nearby home station in Distt. Kangra and Chamba, H.P, against longer stayee by clubbing his/her previous stay.

Whereas, from perusal of record, it has been found that the petitioner is working at GSSS Badgran, Distt. Chamba, w.e.f. 26-02-2021 and has completed two winters & three summers at her present place of posting which is a hard/sub-cadre area. One Sh. Raj Kumar, TGT(NM) is working in GMS Thehru, U/C GSSS Bhalad, Distt. Kangra, H.P since 07-03-2022. The petitioner has given willingness for her transfer to the aforesaid school against longer stay by clubbing his previous stay within radius of 30 Kms.. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and She is hereby transferred without TTA from GSSS Badgran, Distt. Chamba, H.P to GMS Thehru, U/C GSSS Bhalad, Distt. Kangra, H.P vice Sh. Raj Kumar, TGT(NM), by clubbing his previous stay within radius of 30 Kms., with TTA/JT to Sh. Raj Kumar, TGT(NM). The representation of the petitioner is disposed of accordingly.

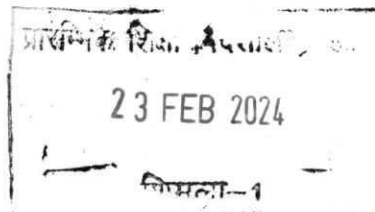
