The petitioner has given willingness for her transfer to the aforesaid school against longer stay by clubbing his previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and She is hereby transferred without TTA from GSSS Badgran, Distt. Chamba, H.P to GMS Thehru, U/C GSSS Bhalad, Distt. Kangra, H.P vice Sh. Raj Kumar, TGT(NM), by clubbing his previous stay within radius of 30 Kms., with TTA/JT to Sh. Raj Kumar, TGT(NM). The representation of the petitioner is disposed of accordingly.
