CWP No. 8405/2023 titled as Ankuj Kumar Vs. State of H.P. & others.

Whereas, Sh. Ankuj Kumar, TGT (NM) preferred CWP No. 8405/2023 titled as Ankuj Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Rupari u/c GSSS Bamta District Shimla to the station nearby his native place Distt. Kangra, against vacancy/ longer Stayee. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 03.11.2023 when the Hon'ble High Court has passed the following orders:-

"6. Without going into the merits of the hardships, if any, this Court, disposes of, the instant writ petition, by directing the Respondent No. 2-Director of Elementary Education, Himachal Pradesh, to decide the representation and to make an effort to redress the hardship(s), if any, by passing appropriate orders, in accordance with law, by taking into account the norms governing transfers and also the mandate of law in case of Shilpi Bose (supra) within two weeks thereafter.

As aforesaid, the instant writ petition, as well as, the pending miscellaneous application(s), if any, shall also stand disposed of."

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 05.12.2023. He has attended the same and submitted his representation in this office on 05-12-2023 vide which he has requested that he has completed required tenure at his present place of posting i.e GMS Rupari u/c GSSS Bamta District Shimla, H.P and he further requested that he may be transferred to Distt. Kangra, against vacancy/ longer stayee by clubbing his/her previous stay. Petitioner has given five stations of his choice in District Kangra.

Whereas, from perusal of record, it has been found that the petitioner is working at GMS Rupari u/c GSSS Bamta District Shimla w.e.f. 14.11.2019 and has completed more than three years stay at present place of posting. One Sh. Vivek Kumar TGT (NM) is working in GMS Attara u/c GGSSS Gangath, Distt. Kangra since 26.07.2021. The petitioner has given willingness for his transfer to the aforesaid school against longer stay by clubbing his previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and he is hereby transferred without TTA from GMS Rupari u/c GSSS Bamta, Distt. Shimla to GMS Attara u/c GGSSS Gangath, Distt. Kangra, vice Sh. Vivek Kumar, TGT (NM) against longer stay by clubbing his previous stay within radius of 30 Kms with TTA/JT to Sh. Vivek Kumar, TGT (NM). The representation of the petitioner is disposed of accordingly.

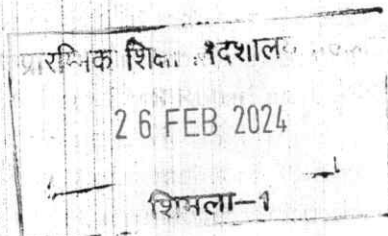

Whereas, Sh. Ravi Dutt, TGT (NM) preferred CWP No. 6936/2023 titled as Ravi Dutt, TGT(NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GSSS Nanj, Distt. Mandi to Distt. Hamirpur. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 27-09-2023 when the Hon'ble High Court has passed the following orders:-

" 5. In this view of the matter, the petitioner is permitted to submit a frsh representation to respondent No.2 within two weeks from today. On receipt of representation of the petitioner, respondent No.2 shall consider and decide the same strictly in terms of the transfer policy adopted by the State Government within further two weeks' period by passing a speaking order. Needless to say that in case the petitioner is found eligible to be transferred to the place of his choice in term of the transfer policy, necessary orders shall be immediately issued by the respondents".

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 20-11-2023. He attended the same and submitted his representation in this office on 20-11-2023, vide which he has requested that he has completed required tenure at his present place of posting and he further requested that he may be transferred to nearby home station in Distt. Hamirpur, against vacancy/ longer stayee.

Whereas, from perusal of record, it has been found that the petitioner is working at GMS Nanj, Distt. Mandi, H.P w.e.f. 04-09-2018 and has completed the normal tenure of three years. One Sh. Sukesh Kumar, TGT(NM) is working in GSSS Toni Devi, Distt. Hamirpur, H.P since 02-09-2022. The petitioner has given willingness for his transfer to the aforesaid school against longer stay by clubbing his previous stay within radius of 30 Kms.. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and he is hereby transferred without TTA from GSSS Nanj, Distt. Mandi to GSSS Toni Devi, Distt. Hamirpur, H.P, vice Sh. Sukesh Kumar, TGT(NM), by clubbing his previous stay within radius of 30 Kms., with TTA/JT to Sh. Sukesh Kumar, TGT(NM). The representation of the petitioner is disposed of accordingly.
