- It must be ensured that the candidate is not specially abled.
- It must be ensured that the incumbent is not on the verge of retirement.
- The transfer orders of TGTs issued from hard area to soft area may not be implemented without joining of substitute.
- If incumbent (s) who has/have not completed three years tenure in his/her present place of posting, transfer orders may not be implemented, if stay of the incumbent (s) not condoned.
- All provisions as contained in O/M No:PER (AP-3)E(3)17/2021 dated 10.07.2013 "Comprehensive Guiding Principles 2013" for regulating the transfer of State Govt. Employees at point No.5" concession to certain categories of employees and 5.5. of O/M dated 17.9.15 must be adhered strictly.
