Distribution of supplementary nutrition items (top-up) i.e. boiled eggs/fruits(preferably Banana or Apple of good quality) as per the choice of the students/guardians once in a week preferably on Wednesday alongwith mid day meal to the eligible students of classes Nursery to Eighth grade in the State under "Mukhya Mantri Bal Paushtik Aahaar Yojna".

Sir,

Your kind attention is drawn towards this office letter of even No dated 23.08.2024 vide which the requisite budget was allotted through e-vitran (Treasury Route) to you for the implementation of "Mukhya Mantri Bal Paushtik Aahaar Yojna" during financial year 2024-25. As per the instructions issued vide above referred letter, supplementary nutrition items (top –up) i.e. boiled eggs/fruits (preferably Banana or Apple of good quality) as per the choice of the students/guardians once in a week preferably on Wednesday alongwith mid day meal are mandatorily required to be distributed to all eligible students of classes Nursery to Eighth grade in the State under aforesaid Yojna. However, the said instructions are once again attached herewith for implementation at school level.

In this context, it has come to the notice of the Department, that in certain schools very poor quality fruits or otherwise rotten fruits are being distributed to the eligible students in schools under "Mukhya Mantri Bal Paushtik Aahaar Yojna" which has been viewed seriously by the undersigned.

In view of the above, all field functionaries i.e. all DDEE's, BEEO's and CHT's as well as Senior Most Teachers and Mid Day Meal Incharge Teachers of the respective schools may ensure the provision and distribution of good quality fresh fruits (preferably Banana or Apple) or boiled eggs to the eligible school students under "Mukhya Mantri Bal Paushtik Aahaar Yojna". Moreso, all field functionaries are also requested to inspect the distribution of above said food items to the eligible school students under "Mukhya Mantri Bal Paushtik Aahaar Yojna" in their respective schools from time to time and if the distribution of poor quality fruits or eggs are found in any schools, the same may be viewed seriously and stern disciplinary action may be taken against the erring school officials under CCS (CCA) Rules under intimations to the higher authorities.

This may be treated as most urgent and personal attention & top priority be given in the matter please.
