ORDER

Sh. Suresh Kumar TGT (A) presently working in GSSS Bhakra (BLS) has filed CWP No.562/2020 before the Hon'ble High Court regarding transfer from the present school. CWP was disposed of on 21.8.2020 with the following directions:-

"It is represented by the Ld. Counsel for the petitioner in CWP No:562/2020 that his client is having personal difficulty that is why he has sought his transfer and now that the transfer has been cancelled, he may be permitted to make representation. The request appears to be innocuous and is allowed. The petitioner in CWP No: 562 of 2020 will make a representation to the respondents/competent authority which shall be decided within a period of four weeks from the receipt thereof.

From perusal of record it has been noticed that Sh. Suresh Chand TGT (Arts) GSSS Bhakra (BLS) was transferred from GSSS Bhakra (BLP) to GSSS Gandhir (BLP) vice Sh. Prakash Chand TGT (Arts) on vice versa basis vide this Directorate O/o No: EDN-H(2)B(6)1-18/2020-Arts on dated 13.01.2020. The Hon'ble High Court granted relief to Sh Prakash Chand TGT (Arts) resultantly the petitioner is still working in GSSS Bhakra (BLS). Now vide representation received on 09.09.2020 he has requested for transfer on any of the following stations:-

- a)GSSS Daslehra (BLP), b) GMS Gujrehra (BLP), C) GSSS Berthin (BLP)
d)GSSS Gandhir

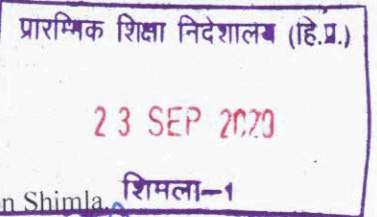
Presently there is no vacancy in any of the above schools hence, request of the petitioner to transfer him from GSSS Bhakra (BLP) cannot be acceded to.
