NOTIFICATION

The issue regarding reimbursement of cost of Cochlear Implant Surgery to the Govt. employees /Pensioners was engaging the attention of the Government for the past some time. The Governor of Himachal Pradesh is pleased to lay down the following procedure for reimbursement of Cochlear Implant Surgery to Govt. employees/ Pensioners:

1. Request of the beneficiary should be accompanied by a certificate of surgical necessity issue by a Medical Officer (Specialist)/Medical Education Faculty that the cochlear implant surgery is necessary.
2. The beneficiary would apply to the Director Medical Education & Research along with the following documents:-
 - a) Surgical necessity Certificate.
 - b) Complete Clinical details and report of relevant investigations
 - c) Undertaking to the effect that he/she has not claimed reimbursement of the cost of the treatment from other sources like National Health Mission, MMCSK etc.
3. The Director Medical Education & Research shall forward and get the genuineness of the necessity examined by a committee comprising of the following:
 - a) The Principal, IGMC, Shimla.
 - b) The Professor & Head, Department of Paediatrics, IGMC, Shimla.
 - c) The Professor & Head, Department of ENT, IGMC, Shimla.
4. The committee may seek clarifications like additional reports etc., if required from the beneficiary and make their recommendations to the Director Medical Education.
5. The Director Medical Education & Research shall issue approval for reimbursement of the charges of the Cochlear Implant Surgery subject to the capping prescribed as per CGHS Rules.
