Your name has been sponsored by the Office-in-charge (Placement) Special Employment Exchange, Directorate of Labour and Employment Himachal Pradesh or you have applied directly for the post of TGT (Arts/Non-Medical/Medical) under Physically Handicapped quota.

You are, therefore, requested to appear in person for the counselling on the scheduled date, time and venue. You are required to bring the original certificates/degree of examinations passed, alongwith one set of attested copies of the following documents while attending the counseling:-

1. Matriculation & 10+2 Certificates.
2. BA/B.Com/B.Sc. & B.Ed Degree with detail marks sheet.
3. Certificate of additional qualification if any.



4. Character Certificate.
5. Bonafide Himachali Certificate.
6. Passport size photograph (one).
7. Permanent Physically Handicapped Category Certificate.
8. Teacher Eligibility Test issued from HPSSSB Hamirpur or Board of School Education, Dharamshala.

It is further apprised that the Department of Social Justice and Empowerment H.P. vide letter No: SJE-B-(15)-03/2014-I dated 23.8.17 has approved following criteria to fill-up posts reserved for the Persons with disabilities:-

**Note:-** 1. The certificate of Backward Area /Panchayat, Landless family/family having less than 1 hectare land, non-employment/income certificate etc. shall be issued by the concerned SDO(C), Tehsildar/Naib Tehsildar.

2. The BPL certificate, widow/divorced/destitute/single woman/single daughter/orphan etc. shall be certified/issued by the concerned BDO by taking the authenticated entries in the 'Parivar Register' as the basis of such certificate.

3. Differently abled person certificate shall be issued by the H&FW authorities/Medical Boards.

If the candidate is in possession of any above certificates (as per criteria) he or she also brings the same.

All documents/certificates must be duly attested/Self attested. No TA/DA will be admissible for this purpose.

The candidate also must ensure that they are eligible as per following identification of post:-



Provided this condition is not applied to Bonafide Himachalis. Candidate who has not passed Teacher Eligibility Test from HPSSSB Hamirpur or Board of School Education Dharamshala are also not eligible for the post.
