

1. The certificate of Backward Area /Panchayat, Landless family/family having less than 1 hactare land, nonemployment/income certificate etc. shall be issued by the concerned SDO(C), Tehsildar/Naib Tehsildar.

2. The BPL certificate, widow/divorced/destitute/single woman/single daughter/orphan etc. shall be certified/issued by the concerned BDO by taking the authenticated entries in the 'Parivar Register' as the basis of such certificate.

3. Differently abled person certificate shall be issued by the H&FW authorities/Medical Boards.

If the candidate is in possession of any above certificates (as per criteria) he or she also brings the same. All documents/certificates must be duly attested/Self attested. Candidate who has not passed Teacher Eligibility Test from HPSSSB Hamirpur or Board of School Education Dharamshala are also not eligible for the post.
