In the matter of:- CWP No. 3958 /2020- Sh. Sanjeev Kumar, TGT (NM) Vs. State of H.P. and others.

Whereas, Sh. Sanjeev kumar, TGT (NM) presently working in GSSS, Sunara Distt. Chamba has filed CWP No. 3958/2020- titled as Sanjeev Kumar, TGT (NM) Vs. State of Himachal Pradesh, regarding transfer from GSSS, Sunara Distt. Chamba to Distt. Kangra or Distt. Hamirpur, H.P to the stations of his choice after the completion of required tenure as per policy. The case of the petitioner was listed before the Hon'ble High Court of Himachal Pradesh on 24.09.2020 when after hearing the matter, the Hon'ble High Court of Himachal Pradesh, has disposed of the same with the following directions /order:-

"Consequently, this petition is disposed of with liberty to the petitioner to make fresh representation to the respondent/authorities, concerned giving five stations of his choice, within one week from today, in accordance with the transfer policy. On receipt of such representation, the respondent/authorities shall consider the representation of the petitioner, in the light of the transfer policy occupying the field, and pass appropriate orders, within two weeks. It is clarified that while deciding the representation of the petitioner the respondent shall considered the stations of choice of the petitioner as mentioned in his representation subject of the condition that the incumbents posted their have completed their normal tenure of posting, in accordance with the transfer policy. In case none of them have completed the normal tenure then the office of the respondent/authorities shall get in touch with the petitioner apprising him of vacant stations where the incumbents have completed their normal tenure and the possible places where the petitioner can be posted. Pending application(s), if any, are closed.

As per directions of the Hon'ble High Court, the petitioner has attended personal hearing on 23.10.20 and requested that due to his domestic problem he may be adjusted in GSSS Alampur (KGR)/GHS Barram (KGR)/ GHS Balahra (KGR)/GMS Dhail u/c GSSS Rangar (HMR)/ GMS Khanauli u/c GSSS Rakkar (HMR).

On the perusal of the record, it is found that the petitioner is working in GSSS, Sunara Distt. Chamba w.e.f. 22.2.17 and has completed his normal tenure at his present place of posting. GSSS, Sunara Distt. Chamba falls in Sub- Cadre Area. At present the post of TGT (NM) is lying vacant in GSSS Alampur Distt. Kangra.

Therefore, keeping in view the position stated above, the representation made by Sh. Sanjeev Kumar, TGT (NM) is considered sympathetically and is hereby transferred from GSSS, Sunara Distt. Chamba to GSSS, Alampur Distt. Kangra against vacancy without TTA/JT. The representation of the petitioner is disposed of accordingly.
