In the matter of: CWP No:5976/2020-titled as Dhanna Ram, TGT (Arts) Vs. State of Himachal Pradesh (Regarding Transfer)

ORDER

Sh. Dhanna Ram, TGT (Arts) u/t from GSSS Amarapur (BLP) to GSSS Deot (SML) has filed CWP No. 5976/ 2020- before the Hon'ble High Court regarding transfer. The case was listed on 01.01.2021, when the same has been disposed of with the following directions:-

Consequently, the present petition is allowed and the impugned office order dated 15.12.2020 (Annexure P-1) is quashed and set aside. However, respondent No.3 is also permitted to make a representation and in case the same is made within two weeks from today, respondent No.1 and 2 shall consider and decide within a period of four weeks thereafter. Pending application (s) if any, also stands disposed of.

In pursuance to the above said order dated 01.01.2021 passed by the Hon'ble High Court of Himachal Pradesh, the respondent No.3 i.e Smt. Usha Kumari, TGT (Arts) was called for personal hearing on dated 29.01.2021 which was duly attended by her. The petitioner vide representation dated 6.1.2021 has requested for adjustment in Distt. Bilaspur against vacancy which will accrue due to promotion of lecturers. Presently promotion list has not been issued by the Director of Higher Education. The petitioner has also requested for adjustment in Distt. Bilaspur in r/o three schools where vacancy will arise due to superannuation of present incumbents in April 2021 and in June 2021. Since, promotion from TGT to PGT is still awaited and superannuation of TGTs concerned is in April and June 2021, hence the request of the petitioner cannot be considered at this stage.

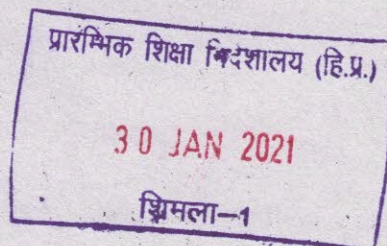


Accordingly representation stands decided.
